Article 6. - Will the corporation have members?

Article 7. - In the event of the dissolution of the Corporation, the Board of Directors shall cause the assets of the Corporation to be distributed as follows:

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or the such organization or organizations organized and the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine.

Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article 8. - The corporation is formed for the following purpose(s):

The mission of the Open Source Ecology is to empower and engage people around the world to build and service their own industrial machinery and establish enterprises based on it. We manage an open source innovation development pipeline that translates conventional technology into the public domain under a free license for everyone's benefit. We also provide hands-on trainings that cover jobs skills and enterprise development as well as distance-education programs to facilitate independent replication of the technology and business plans anywhere in the world.

The Corporation is organized exclusively for educational, scientific, religious and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law). The Corporation shall receive and disburse funds, property and gifts of any kind for any qualifying charitable purpose. The Corporation may use its funding in the operation of any of its facilities and programs and activities and conduct any program, activity and or event, including the publishing of information and educational materials as deem appropriate under the provision of the IRS Code of 1986 or any future provisions of that Code.

Article 9. - The effective date of this document is the date it is filed by the Secretary of State of Missouri unless a future date is otherwise indicated:

Article 10. - Indemnification

The Corporation shall insure and protect its directors from liability, in regards directly to corporate matters, actions and activities, to the full extent allowed by the Laws of Missouri or other laws in any State in which the entity shall operate. This provision shall not extend to conditions in which the Directory knowingly committed fraud or other wrongdoing.

Article 11. - Use of Earnings

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing of distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986 (or

the corresponding provision of any future United States Revenue law) or (b) by a Corporation, contribution to which are tax deductible under Section 170 (c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

The method of distribution of assets shall be as set forth in the Bylaws of the Corporation.

- Article 12. Powers Without limiting the general powers granted to the Corporation by Missouri law, the Corporation shall have the following specific powers:
 - 1. To aid in the fulfillment of the educational and charitable functions of the Corporation by raising and providing funds;
 - 2. To make grants and loans of any corporate property for the purpose of furthering the purposes of the Corporation;
 - 3. To solicit, accept, administer, and disburse gifts of every kind or to hold said property in trust in such manner as the Corporation deems appropriate for the furthering of the purposes of the Corporation;
 - 4. To receive grants from other sources and to disburse such grants for the support of the purposes of the Corporation;
 - 5. To conduct any activities associated, directly or indirectly, with the charitable purposes to include activities that may qualify the organization as an operating foundation as described within the Internal Revenue Service Code of 1986 or any future revision of that code.
 - 6. To make distribution to other or any entity that is exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986 (or any corresponding provision of any future United States Internal Revenue Law).
